

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.Revestinvestments.com and Revest Investments LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Revest Investments LLC include www.Revestinvestments.com and RVI LLC. The RVI LLC website is a Real Estate Buying and Selling site. By using the RVI LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, RVI LLC may collect personally identifiable information, such as your:

- First and Last Name
